Tournament Details: 100 PBIS POINTS

Game Day: March 25, 2025 (during the school day)

Finals: March 27, 2025 (evening event - all participants must have a ride to and from the event)

- 1. Each team roster must have FOUR players.
- 2. Each team member must have 100 PBIS points to participate. Points will be redeemed once the frist 16 teams have been accepted.
- 3. 10 Minute RUNNING CLOCK: NO TIMEOUTS, OVERTIME SUDDEN DEATH FIRST TEAM THAT SCORES WINS.
- 4. Possession of the ball after a score goes to the OPPOSITE TEAM.
- 5. THREE-POINT SHOT IS IN EFFECT (for championship game only)
- 6. All games will be officiated and all normal middle school basketball rules are in effect.

Requirements:

- 1. NO DISCIPLINE MAJORS from February 18, 2025 forward. YOUR TEAM WILL BE DISQUALIFIED.
- 2. Each team member must hand in a signed permission slip/waiver form at the time of registration.
- 3. Participant fee is 100 PBIS points per team player.
- 4. **No absentees** by any member on the day of the tournaments or your team will be disqualified.
- 5. If any team member is removed from the tournament, the ENTIRE TEAM IS DISQUALIFIED: teams will be notified if a situation arises. (You are responsible for your team. Help each other out.)
- 6. No substitutes and no team changes. (Exceptions will be made regarding injuries ONLY and ONLY before the Tournament.)
- 7. First come, first serve on entries. Availability is limited!
- 8. Bring completed forms to the Counseling Center.
- 9. Tournament Dates: March 25th during the day and SEMI-FINALS the evening of March 27th
- 10. Your team Name MUST be appropriate and positive.
- 11. Teams placed on the waiting list will be notified based on the availability of spots due to teams being removed.
- 12. NO POINTS WILL BE REFUNDED if you are disqualified.
- 13. ALL RULES WITHIN THE MULLEN STUDENT HANDBOOK APPLY DURING THE TOURNAMENT. Violators are subject to removal.

ALL 4 team members must fill out the forms signed per team and handed in to the counseling center stapled together.
